Dear Members of the Texas Legislature:

Thank you for the opportunity to present this report on Texas schools' participation in the Seamless Summer Option (SSO) or the Summer Food Service Program (SFSP). Through these Summer Meal Programs, Texas strategically utilizes federal resources to ensure children have access to healthy meals during the summer months. State statute requires certain school districts to operate a program and the Texas Department of Agriculture (TDA) to report on participation and financial impact. The enclosed Summer 2021 and 2022 report outlines the financial gains and losses incurred by school districts. These figures reflect the unique scenarios that occurred during the COVID pandemic. A complex set of factors such as supply chain disruptions; changes to program operations due to regulatory waivers; staffing challenges; and unpredictable participation presented unique challenges and affected district outcomes.

Texas child nutrition professionals rose to the occasion, meeting every obstacle with creativity and dedication. Districts provided a reliable source of nutrition and support for Texas children at a critical time of need. TDA is proud to partner with Texas schools and their child nutrition teams to identify opportunities to support access to summer meals to children across the state. Executive Summary

Texas Agriculture Code Sec. 12.0029 mandates that public school districts must participate in a federally funded Summer Meals Program or request a waiver if 50 percent or more of their students are eligible to receive free or reduced-price meals in the National School Lunch Program (NSLP). In 2021, 764 school districts were identified as mandated and 69 percent of those schools offered the Summer Food Service Program (SFSP) or the Seamless Summer Option (SSO); the latter streamlines the summer meals process for schools already operating NSLP. In 2022, 764 school districts were identified as mandated, of which 70 percent offered SFSP or SSO.

The number of districts seeking waivers in lieu of offering summer meals rose from 201 in 2013 (the first year TDA submitted data) to 235 and 224 waivers granted in 2021 and 2022, respectively. According to waiver requests, a transportation barrier continues to be the most common obstacle keeping school districts from participating. Transportation concerns were cited in 76 percent of the waiver requests submitted in 2021 and 77 percent in 2022.

School districts face a variety of challenges in their efforts to offer a Summer Meals Program. Primarily schools struggle to maintain participation in congregate meal settings during the summer months when students are otherwise not on campus. When program costs outpace program meal reimbursements, budget shortfalls are often resolved with funding from the school food service account, if available, or school district general revenue.

The impact of the COVID pandemic on Summer Meal Programs was unprecedented. In response, the state and federal government worked together to implement program waivers to mitigate the pandemic impact. Each district navigated unique circumstances that resulted in a wide range of financial gains or losses. Districts with significant gains likely had strong community response to multi-day grab-and-go meals and/or incorporated food resources underutilized during the school year due to reduced enrollment. While losses are not uncommon in the Summer Nutrition Programs, some districts incurred greater losses because of pandemic-related operational costs and unpredictable participation.

The lessons learned from the challenges and opportunities during this time are improving state and federal governance of, and support for, the operators of these programs. TDA continues to lead in these policy discussions and advocates on behalf of Texas program operators and the children that depend on the important nutrition from the Summer Meal Programs.

Charge

In 2011, the 82nd Texas Legislature passed Senate Bill 89, directing the Texas Department of Agriculture (TDA) to submit a biennial report regarding school district participation the Summer Meal Programs. This requirement replaced Texas Human Resources Code, §33.024 with Texas Agriculture Code, §12.0029 under the heading SUMMER NUTRITION PROGRAM, which stated as follows:

(j) Not later than December 31 of each even-numbered year, the department shall provide to the legislature by e-mail a report that, for each year of the biennium:

(1) states the name of each school district that receives a notice under Subsection (c) and indicates whether the district:

(A) has provided or arranged for the provision of a summer nutrition program; or

(B) has not provided or arranged for the provision of a program and did not receive a waiver;

(2) identifies the funds, other than federal funds, used by school districts and the state in complying with this section; and

(3) identifies the total amount of any profit made or loss incurred through summer nutrition programs under this section.

(k) The department shall post and maintain on the department's Internet website the most recent report required by Subsection (j).

Background

In 1993, the 73rd Texas Legislature passed Texas Senate Bill 714 which amended Chapter 33 of the Human Resources Code by adding Section 33.024, Summer Food Service Program (SFSP). The amendment required school districts with 60 percent or more of their children eligible for free or reduced-price meals in the National School Lunch Program (NSLP) to participate in SFSP by the summer of 1997. School districts could be granted waivers from participation annually if certain conditions stipulated in the legislation applied.

In 2011, the 82nd Texas Legislature passed Senate Bill 89 requiring public school districts in which 50 percent or more of the enrolled students are eligible to receive free or reduced-price meals in the NSLP to participate in SFSP or SSO or request a waiver from participation. This requirement replaced Texas Human Resources Code, §33.024 with Title 2 of the Texas Agriculture Code, §12.0029.

Participation

In 2021, a total of 764 school districts were subject to the requirements of Texas Agriculture Code, §12.0029 because at least 50 percent of enrolled students were eligible for free or reduced-price meals in the NSLP. Of those 764 school districts, 527 participated in either SSO or SFSP. In 2022, a total of 764 school districts were subject to the same requirements of Texas Agriculture Code, §12.0029. Of those 764 school districts, 538 participated in either SSO or SFSP.

Mandated school districts are required to work with TDA to remove barriers to participation, locate alternate sponsors and process waiver requests. As the following tables shows. in fiscal years 2021, all mandated school districts participated in SFSP or SSO or received a waiver from program participation; in 2022, all mandated schools participated or received a waiver.

The following table provides a comparative overview of the participation waivers requested and granted for 2021 and 2022. Note that Higgins ISD no longer contracts with TDA to participate in the NSLP and are not mandated to offer SFSP or SSO and Coahoma ISD submitted an adjusted claim which dropped them below 50% free and reduced eligible students and removed them from the mandate list as indicated in the table.

Waivers

School districts were granted waivers for the following reasons:

- Enrollment includes fewer than 100 children.
- The cost of transportation is an insurmountable financial obstacle.
- School buildings or cafeterias are under renovation or construction.
- An alternate provider already sponsors a Summer Meals Program in the area, or TDA accepted that there were other extenuating circumstances.
- The school food authority is unable to operate a summer nutrition program because the projected operational expenses for the Summer Meals Program exceed the expected federal reimbursements plus one month of the school food services' three months operating expenses on hand.

- Participants – list of school districts mandated to participate in a Summer Meals Program that either participated or were granted a waiver for fiscal year 2021 (Appendix A) and fiscal year 2022 (Appendix C).
- Costs – list of those school districts mandated to participate in a Summer Meals Program and identified the total amount of any profit made or loss incurred through summer nutrition programs in fiscal year 2021 (Appendix B) and fiscal year 2022 (Appendix D)

Costs

School districts that had 50 percent or more students eligible for free or reduced-price meals are asked to report to TDA the total cost of operating their Summer Meals Program once it has concluded, as well as report any other funds (other than federal funds) that were used to pay for the operation of a Summer Meals Program. Unlike previous reporting periods, pandemic-based program waivers allowed schools the choice to operate the SSO Program as an alternative to the NSLP program during the school year. Among other benefits, this allowed districts to temporarily serve meals at no cost to all students and the community. This unusual program flexibility posed some challenges for schools to separate the cost of operation during the traditional summer period from other school year months. TDA has provided guidance for districts to understand how to accurately separate those cost analysis for the purpose of this report.

TDA deducts the districts' self-reported information from the amount of the federal reimbursements to create the lists of profit/loss by district. TDA asks if other non-federal funds are used to operate the programs although the reporting by schools is inconsistent. Those district costs are reported in Appendix B (2021) and Appendix D (2022) for the districts that reported them. The most common scenario is that school nutrition programs utilize the non-profit school food service account to resolve deficits caused by operating a Summer Meal Program. If the school food service account is not sufficient, schools are required to eliminate the deficit and most commonly use district general funds. TDA did not incur costs above federal funds to comply with Texas Agriculture Code, §12.0029.
